IDF Network of Overseas Indians

The India Development Foundation of Overseas Indians (IDF-OI) is a not-for-profit trust established by the Ministry of Overseas Indian Affairs (MOIA), in 2008, to serve as a credible institutional avenue to enable overseas Indians to engage in philanthropy with social and development projects in India. The Trust is exempt from the provisions of the Foreign Contributions Regulation Act (FCRA), 2010.

Objectives of the Trust:

- Lead philanthropy by overseas Indians into India and facilitate philanthropic partnerships.
- Provide a list of credible institutions, projects and programmes to overseas Indians.
- Function as a clearing house for all philanthropy related information on India.
- Partner with and encourage credible philanthropic organisations.
- Promote accountability and 'good practices' in overseas Indian philanthropy.

IDF-OI is administered by a Board of Trustees, chaired by Smt. Sushma Swaraj, Hon'ble Minister of External Affairs and Overseas Indian Affairs. The other Board members are prominent overseas Indians- Shri. Yusuff Ali, Shri. Joginder Pal Sanger, Shri. Subhash Jindal, Shri. B.K. Agnihotri and eminent Indians- Dr. Bindeshwar Pathak, Smt. Ritu Beri, Shri. Ashok Chowgule and Shri. Varaprasad Reddy, who have an active interest in philanthropy. Senior Government of India officials from Ministries of Home Affairs, External Affairs, Finance and NITI Aayog are also Board members.

How you can give back

Overseas Indians can identify a project in totality or an individual component from the selection showcased on IDF-OI website. Payment can be made through bank transfer to IDF-OI's bank account, specifying the project details. The projects will be monitored by the implementing agency which will report regularly to IDF-OI and the contributor during and after project implementation. Regular feedback reports will be sent every quarter regarding impact of the project, photos/videos of actual beneficiary or project site and quarterly accounts of project expenditures.

Projects funded through IDF-OI will acknowledge the contribution of the overseas Indians and IDF-OI. The plaque/ board/ acknowledgement of overseas Indian's contribution, at the project site, may state "In Honour of; In memory of; On the occasion of" or any other message.

Giving back to Swachh Bharat Mission



Swachh Bharat Abhiyaan is not just about cleaning surroundings but also seeking the participation of people in planting trees, creating a garbage-free environment, providing sanitation facilities and paving the way to accomplishment of the vision of a 'Clean India' by October 2, 2019, the 150th birth anniversary of Mahatma Gandhi.


